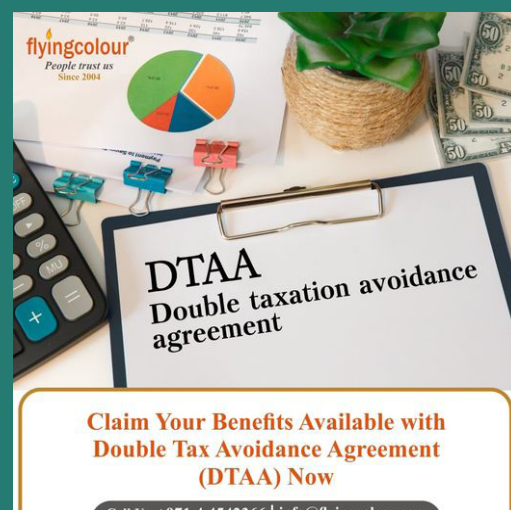


VAT Recovery Under Expo 2020

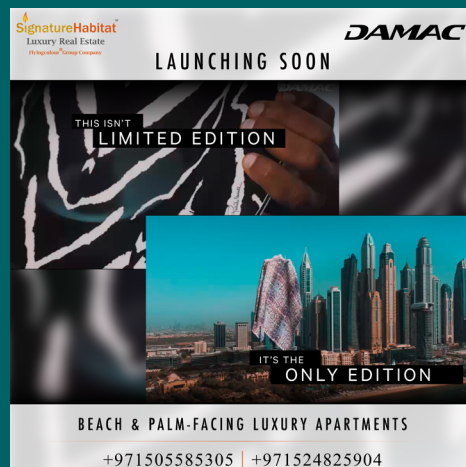

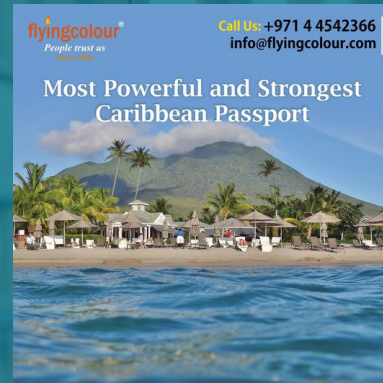

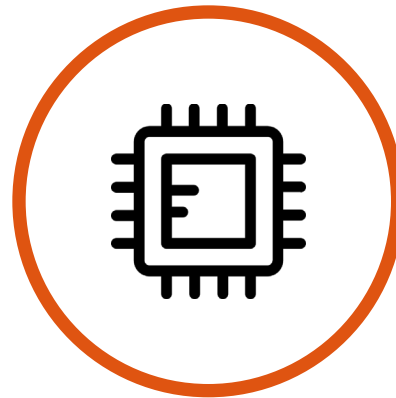
